When Will D-5 Councilman Pequeno apologize for his comments towards me at the 05-07-24 council meeting regarding Vector control response to mosquito abatement on the “Alton Side” of Foothill Ranch? I provide 3 photos all generated by Vector Control.

When will D-5 councilman take a leadership role regarding the dangerous propane tanks next to a flammable canopy and trees cooking contaminated meat and chicken at the corner of El Toro and Rockfield? Literally, walking distance from his home. Numerous code violations.

When will D-5 councilman Pequeno return the \$500 campaign contribution from D-2 councilman Benjamin Yu. Form 460 “Campaign Contribution” page1 and 7 attached. Benjamin Yu has been arrested for a **FELONY** under California PC:

273.5(a) Any person who willfully inflicts upon a person who is his or her spouse, former spouse, cohabitant, former cohabitant, or the mother or father of his or her child, corporal injury resulting in a traumatic condition is guilty of a **FELONY**.

Superior Court Case number 23HM04775

243.D Battery causing serious bodily injury (CALCRIM 925) is another famous “wobbler” crime that can be charged as either a misdemeanor or a felony offense. If convicted of a PC 243(d) misdemeanor, the penalties are a maximum of one year in county jail, a \$1,000 fine plus penalty assessments, or both.

273.5(a) Any person who willfully inflicts upon a person who is his or her spouse, former spouse, cohabitant, former cohabitant, or the mother or father of his or her child, corporal injury resulting in a traumatic condition is guilty of a felony.

148(a)1 violated when one obstructs an officer or EMT when the officer or EMT is performing his or her duties. The prosecution must prove that the defendant knew or should have known that the person affected was an officer or an EMT performing such duties.

273(6)b Any intentional and knowing violation of a protective order is a misdemeanor crime punishable by up to one year in county jail, and fine of up to \$1,000, or both jail and a fine.

## **CONSENT CALENDAR**

### **#6 Kidder-Matthews \$2,313,920.34 3-year contract.**

This is ridiculous. I never understand why we spend \$771,306.00 per year or \$64,276.00 per month to operate this complex. Finished in 2019, the equipment will function for many years. Spending \$60K per year for a “building engineer” to monitor HVAC and lights from a desktop computer, when everything is automated is wasteful spending. There is only 1 building operating daily and that’s the 2 story administrative offices. The “Clubhouse” is used a few hours a day. “Council Chambers” twice a month for 8 hours. Making a big deal over two elevators. One in the administrative building and another in the parking garage. The Grove is barely used. Kidder-Matthews charging 15% for every transaction is ridiculous. We have a capable facility manager in Kay Yoshino who can oversee the complex.

I was the operations manager for GT Bicycles from 1993-2000 overseeing a 175K square foot distribution facility; 50K square feet assembly area; 65K square feet manufacturing including a heat-treating oven; 25K square feet R&D center and 60K square feet administrative offices, with 125 employees. We’re acting we have a big when reality it’s just a small operation. When can the mayor, Kidder-Matthews and myself with Kay Yoshino sit down and review this proposal?

### **#7 Shopping Center Analysis \$92,010.00 Kosmont Companies**

885 residents participated in the TruNorth Survey. 12% said “Attract new restaurants/stores” (106 residents)

Many centers have been remodeled. Recently the Carlen Center at the Corner of El Toro and Raymond is completed.

ALDI’s is renovating the CVS location on Muirlands and Jeronimo.

Target and WAL MART have both modernized their operations.

Angeleo’s has moved into the Carl’s JR, El Toro at Muirlands

Morena’s Mexican Restaurant has moved into MIMI’s

Warehouse Distribution Center one mile away from the MEADOWS and Baker Ranch is being proposed. Irvine is building modern office buildings and Lake Forest is building a 24 x 7 x 365 Distribution Center

Foothill Ranch Towne Center Mixed Use in the 2040 Plan shows housing being developed where restaurants and the movie theater are now operating.

Cost of eating out is very expensive. Families are watching discretionary spending and eating out is a LUXURY, not a necessity.

Seriously?? Taxpayers are paying for this? Why?

### **#8 CDBG Widan Engineering**

Remember last meeting when CIRBO said “staff” did a great job on the CDBG report” Then if staff is able to do, why are we paying Widan Engineering all this money? Previously Mike Linares did the same work for half the cost, and was not allowed to bid on the project. We paid Mike Linares \$34,762.42 per “Vendor Purchase Report” From 01-01-23 thru 12-31-23

Wildan Engineering cost is \$75,267.00 per year. Double of Mike Lindares. I never heard any problems with Mike Lindares so why are we paying DOUBLE???

## **DISCUSSION-ACTION ITEMS**

### **#10 ACC-OC AWARD**

Now I see where taxpayers \$15,300 membership fee went! We received an award for the BOGO program that was financed by the Federal Government with COVID \$\$\$\$. Yiftee got a no bid contract because City Manager Rose said we didn’t have time for other bids, “We need to get this started before the holidays”

### **#11 OCSD Contract**

2022-23 \$19,707,131 32 Patrol Deputies. 3.7% increase

2023-24 \$20,288,573 31 Patrol Deputies. 3.0% increase

2024-25 \$21,360,473 31 Patrol Deputies. 5.29% increase

In past years the increase was below 4%. 2024-24 5.29% INCREASE

It's due to the sweet deals that the County Board of Supervisors unanimously vote to approve with the sheriff's union. Association of Orange County Deputy Sheriffs (AOCDS). They basically give them whatever they want.

AOCDS heavily funds the supervisor campaigns. funding about \$300,000 in campaign activity for D-3 Supervisor Don Wagner. ***No city representation at the collective bargaining table.*** The county votes, we pay. Lake Forest government never questions the actions of the Supervisors. Never asks them to hold down the contract costs. We just have to pay the bill after the damage is done. If you want to look at how much OCSD deputies make, simply go over to the Transparent California website. It's all there and quite shocking.

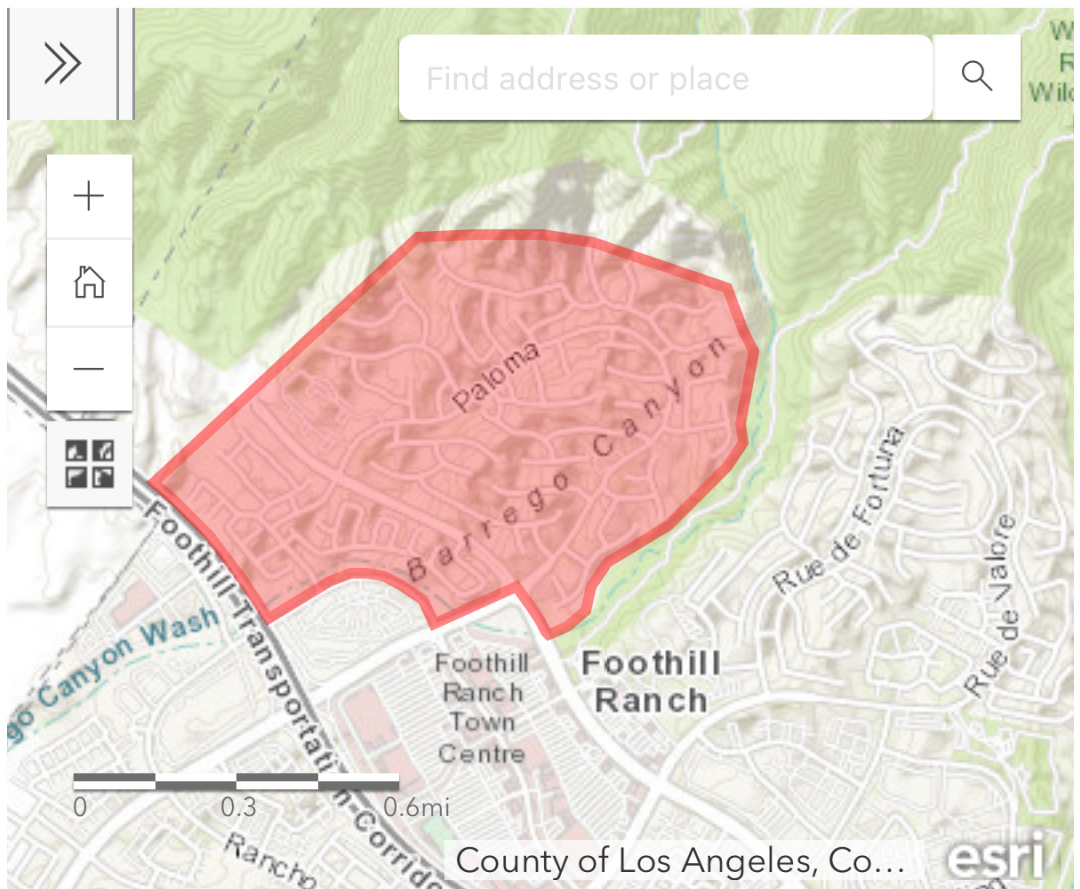
# Irvine Treatment Application Dates and Times:
