DD form 214 military discharge, still have not produced.

” I was not on the council” when the decision was made about the elementary school. Attended all the community meetings when Toll Brothers were making the presentations.

Rancho Parkway landscaping issue in front of the Mongolian BBQ and Shell gas station, dead grass, overgrown weeds.

Waste Fraud and Abuse is prevalent in this administration, I can say is a cancer. From the CM to the CC, each of you are “doing your own thing” and not responsive for the residents. It’s actually shocking to observe what is happening. The sad thing is you all believe you’re doing a “great job” There is no accountability between the council members. When I as a resident point out a blatant behavior issue, the other council members ignore. Therefore, the behavior continues. Consequences? None!!

The CM works “behind the scenes” by authorizing activities below \$50K threshold. First, for security enforcement for food vendors. This expense was never discussed at a council meeting. Next, purchase of 2 E-Bikes for \$20K and training for \$3K. I’ve asked twice, no reply! Why can’t a resident get a reply for 2 e-bikes what department these are for?

Behind the scenes, city attorney Matthew Richardson is telling the council to keep quiet and don’t answer questions from the public on any subject.

Foothill Ranch residents paid Mello-Roos which included funding to build OCFA Station 54. These 10 developers promoted “No Mello-Roos” yet OCFA station #54 services these neighborhoods!!

#1212 Selection of Mayor and Mayor Pro Tem for 2025.

On January 29, 2019, Voigts and his wife filed a Complaint against Defendant in Orange County Superior Court, Case No. 30-2019-01047566 ("the Lawsuit") Sued the residents for \$550,000.00 with a frivolous lawsuit claiming the “divot” in the sidewalk at Pittsford Park caused Voigts to fall out of his wheelchair causing a leg injury. Actually, his own dog pulled him out of the wheelchair causing the injury. \$150,000.00 settlement \$15,000.00 pain and suffering to the wife.

SUNSTAR Labs:

Voigts 460 report of campaign contributors no report of the \$5K contribution from Sun Star Labs. There are very strict rules about contributions, even receiving sporting tickets and dinners must be reported."

At the June 15, 2021 council meeting, a resident submitted a written comment to the council on Item 12 - the repeal of the weed lab testing 331 Ordinance. It's posted under the supplemental material.

The resident brought the council's attention to Voigts's persistence in getting the weed testing labs approved.

Of interest, back on November 15, 2016 Voigts voted to enact Ordinance #289 - which banned all weed operations in Lake Forest, to include MJ testing. He never said that he wanted testing removed from the Ordinance.

Then On September 17, 2019 our city council reviewed a zoning code amendment that would allow marijuana testing in Lake Forest. After prolonged discussion, Voigts motioned to approve the amendment. The motion died for lack of a second.

Next, on January 07, 2020, Voigts motioned to amend and bring back another attempt to establish marijuana lab testing in Lake Forest. This time Voigt received consensus, which set the wheels in motion for Ordinance 331.

In March 2020 Ordinance 331 passed by a 3-2 vote.

The discussion of the repeal of Ord. 331 (marijuana lab testing) in 2021 was preceded by a public statement made by then Chief of Police Services of Lake Forest, OCSD Captain Chad Taylor, at a council meeting that his department declined to do background checks on the 2 permitted businesses since the ordinance was associated with a violation of Federal law. Shortly thereafter, a motion was made to revoke Ordinance 331.

About a year later, on March 16, 2021, the council discussed the repeal of Ordinance 331 (Item 19). Mayor Voigts motioned to table the item indefinitely with no established date to bring the matter back for more discussion. The motion died for lack of a second. Once Voigts realized that there was no support from any of his colleagues, he capitulated and voted to prepare the necessary paperwork to repeal Ordinance 331. 5-0 vote!

On June 1, 2021, Item 11 was a discussion over the repeal. At 1:16:25 time stamp Voigts said "our youth and MANY of our senior citizens are using it" (how would he know that?) but added a disclaimer that he doesn't touch the stuff. Since he knew he was the odd man out and that the rest of the council was going to vote to repeal - he voted to repeal as well, even though he was the stinking ringleader who fought to have weed testing approved in LF. The epitome of a phony.

On June 15, 2021, the council formally adopted Ordinance 347, the repeal (Item 12). Voigts was absent from the meeting.

In the meantime, city attorney Mal Richardson from BB&K watched this circus, and continued billing the city, at a cost of over \$100,000.00!!

Very, very strange course of events. Connect the dots.

Campaign Contributions: Raised \$20K, but ran unopposed, why were contributions accepted. Where is the \$20K???

Mileage Reimbursement: Submitted numerous mileage reimbursement from home to the Civic Center,

ALDI Grand Opening: November 2024, took a \$10 gift card that was for a resident "waiting in line"

JUNKETS Attends conferences, ACC-OC & League of California Cities spending thousands of dollars. Never making a written or "oral report" to the residents. Spring 2024 travelled to Washington DC for the ACC-OC Conference never reporting verbally or written reports. Spending \$1,800 with no report to the residents.

Conflict of Interest "Chief of Staff" to D-2 OC Supervisor Don Wagner, does not recuse himself when voting on county contracts, OCSD annual budget.

Harassment Complaint filed by a previous female city council member who later resigned.

Benjamin Miao Yu:

"Small Business Owner" Refuses to report what these "small business are!! What is Omni Partners LLC?

Benjamin Yu allowed to be on the council with 2 domestic violence arrests! with a felony is ridiculous. I want Benjamin Yu off the council until the 2 cases are judicated. I don't care if Yu wants to "sue the city". Go ahead, let's see now if he

continues to “kick the can down the alley” It is ridiculous Yu is allowed to serve while his victims suffer. This is what I said in my beginning statement that there is no accountability amongst the council members.

On Dec 17, 2024, the council will once again appoint our new Mayor and Mayor Pro Tem for 2025. Moreover, my opinion is that Mr. YU should not be considered for Mayor Pro Tem for 2025, even though, once again, he is next in line sequentially for that position. Criminal charges against Mr. YU, to include felony domestic violence, are still being adjudicated in our justice system. These pending charges place the City of Lake Forest in a very precarious situation. As an elected official, Mr. YU's legal matters are a reflection upon our City. In the best interests of our city, and until Mr. YU's criminal charges are fully adjudicated and resolved, I believe he should not be appointed to a position of even greater authority.

11 appearances in Court for 2 domestic violence arrests in June 2023 and February 2024, still hasn't entered a plea of guilty or not guilty.

Arrested for a DUI Irvine California.

#13 Recognition for Mayor Tetteimer for his “Leadership”

The Lake Forest City Council on Tuesday selected [Mark Tetterer](#) to serve as Mayor and [Neeki4LakeForest](#) to serve as Mayor Pro Tem for the coming year. Both were elected in November, although Tetterer also served the City Council from 2004 to 2012. The two join incumbents Leah Basile, Dwight Robinson and Scott Voigts, also re-elected in November, on the Council. November marked the City's first elections by geographic districts.
