

ADDENDUM TO VONAGE BUSINESS SERVICE TERMS

Sales Order # 559833 & 559855

This Addendum is executed by and between Vonage Business Inc. ("Vonage Business") and the customer identified in the signature block below ("Customer"). This Addendum supplements or amends the terms and conditions set forth in the Master Services Agreement between Vonage Business and Customer dated May 21, 2019 (the "Service Terms"), which are referenced in and made part of the Sales Order. To the extent of any inconsistency between this Addendum and the Service Terms, this Addendum will control. Except as amended or supplemented by this Addendum, the Service Terms otherwise remain unchanged and in full force and effect. Defined terms in this Addendum have the same meaning given such terms in the Service Terms.

The Parties hereby agree as follows:

1. SALES ORDER CO-TERMINUS.

The Service Term for the above-referenced Sales Orders shall run co-terminus with Customer's existing Service Term, Sales Order #Q874355, with a co-terminus contract end date of December 19, 2022.

2. RENEWAL TERM

The auto-renew provision in the Service Terms is hereby modified to state that upon expiration of the Initial Service Term, the Services will be provided on a month-to-month basis for up to an additional ninety (90) days. Customer may terminate the month-to-month period by providing at least 30 days' advanced written notice. Upon expiration of the 90-day period, absent execution of a renewal agreement acceptable to and signed by both Vonage and Customer, the Sales Order will automatically renew for a one (1) year Renewal Service Term (with automatic renewal of subsequent Renewal Service Terms). Upon termination of the applicable Service Term, Vonage will not be obligated to furnish the Services to Customer; provided, however, if Vonage continues to provide Services and Customer accepts and continues to use the Services after termination of the Service Term, such use shall be on a month-to-month basis. During any such month-to-month term, Customer's monthly recurring charges shall increase by 20%.
